1. Subject: Orientation of Research Volunteers at 2nd Army Fort Meade Maryland and Columbus General Depot, Columbus, Ohio.

2. Purpose: To obtain twenty human volunteers for Cml C Medical Laboratories research program.

4. Agencies Represented: Capt John R. Jarvis, Capt William L. Camper, Jr., Cml C Medical Laboratories, Capt St Clair and 2 enlisted assistants, 2nd Army Personnel Office, Col D. Armitage, Major Hans Engel, 2nd Army Chemical Office, At Columbus General Depot the Cml C Medical Laboratories' representatives met with the Commanding Officer, 63rd Engineer Company and his officers: Lt. Mount, CO; Lt Sommerfield, Exed Officer; and Lt Hayes, Personnel Officer. Also contacted was the General Depot Comptroller's office for funding arrangements.

5. Summary: The Orientation Team sent to Fort Meade and Columbus General Depot upon notice by 2nd Army that volunteers were available for orientation. We met with the assembled volunteers at designated areas and orientated the men. Explained to them were: a) type test programs to expect, b) Army Chemical Center and its facilities, c) administrative procedures at the Center, d) full explanation of the volunteer application form.

Upon completion of the orientation at both places a total of approximately twenty volunteers signed up for June to take part in Cml C Medical Laboratories' test over a 30-day period. There were other men who expressed a desire to come in the future and they were also processed and their papers given to local representatives Capt St Clair, 2nd Army, and Lt Mount, 63rd Eng. Comp.
