Dear Dr. Langham:

I am very sorry to learn of the difficulties you are having. After your recent visit I took the opportunity to try to bring the matter to Colonel Warren's attention through Dr. Dowdy, but the last information I had was that Colonel Warren was not going to be able to see Dr. Dowdy until the first week in January.

The urine specimens on subject were sent out in two bottles for November 20 and 21, and December 12 and 13, 1945. Evidently the bottles were not labeled A and B as they should have been. The samples should be combined for analysis.
