

CHRONOLOGICAL LIST OF ACTIONS TAKEN BY DBM RE INQUIRY FROM DR. BURNEY 10/27/58

- 10/27/58 Letter sent from Dr. Burney to Dr. Dunham. 720459
- 10/29/58 Received by Dr. Beard. After verbal discussions with Raw Materials personnel, and others, it was handcarried to Dr. Western and discussed on 11/14/58.
- 11/17/58 Per above discussions, memo was prepared Western to Dunham re setting up meeting, etc.; Dr. Dunham OK'd.
- 11/20/58 Meeting re "Health Hazards in Uranium Mining". Representatives from interested Divisions attended: DBM, L&R, INS, RM, and OGC.
- 11/26/58 Draft of answer to Burney for Dr. Dunham's signature with concurrence and views of interested Divisions. (Concurrence not received as of 12/10/58, prompting interim reply as below on that date.)
- 12/2/58 Draft memo to GM circulated for concurrence. Concurrence never received.
- 12/4/58 Memo to McCool requesting circulation of staff paper.
- 12/8/58 Staff Paper AEC 544/2 distributed.
- 12/10/58 Dr. Dunham acknowledged letter of October 27, 1958 with interim reply.
- 12/19/58 Comments as requested were received by memo from Raw Materials & L&R giving Div. recommendations. Others not received.
- 1/14/59 Meeting with representatives of same Divisions as represented 11/20/58.
- 2/11/59 Memo from Dunham to Olson pressing for OGC decision as requested from OGC pointing out that it had been generally agreed earlier that an OGC decision was necessary to the solution of the problem.
- 2/13/59 Wolf, OGC, answered memo of 2/11 by asking questions.
- 2/20/59 Memo Dunham to Wolf with answers to 2/13/59 memo.
- 2/26/59 Memo Dunham to Olson reiterating need for decision especially due to impending hearings in addition to the need for responding to original letter.
- 3/2/59 GVBeard called Mr. Olson re lack of answer to two memos from Dr. Dunham dated 2/11/59 and 2/26/59. He called back advising he would review that day and we would have memo in our office morning of 3/3/59.
- 3/3/59 Meeting of representatives from same Divisions as of 11/20/58 called so action could be taken on decision (not received by memo from OGC; however, Mr. Olson advised Mr. Charnoff of verbal decision and asked him to represent their office at the meeting.

- 3/5/59 Draft letter GM prepared by DBM & circulated to repr. for concurrence; Memo received 3/6 from Raw Materials. L&R called, INS responded. OGC advised they were rewriting draft and this draft was received 3/9/59 and in turn given to Dr. Western 3/10/59 as Dr. Beard left for OR.
- 3/11/59 Memo Dr. Dunham to GM explaining background of letter to Dr. Burney.
- 3/11/59 Letter to Dr. Burney for GM's signature submitted, signed & sent.
- 3/11/59 Memo Olson to Dunham re our legal stand on matter. (Not received in Division until 3/12/59)

There were in addition numerous telephone calls made by DBM to the various Divisions concerned.
