Subject: Establishment of Project 48C.

To: The District Engineer, Manhattan District, P. O. Box E, Oak Ridge, Tennessee. (Attention: Lt. Col. C. Vanden Bulck.)

1. Reference is made to your letter of 6 November 1944, subject "Increase in Scope of Work under Contract W-7405-eng-48", requesting the establishment of Project 48C under Contract No. W-7405-eng-48 effective as of 1 July 1944. There is inclosed herewith a copy of a letter dated 14 November 1944 to Mr. Underhill from this office outlining the requested change, together with a reply from Mr. Underhill dated February 10, 1945.

2. A letter dated November 14, 1944 from Dr. B.V.A. Low-Beer, outlining the program at the University of California Medical School which will be continued under Project 48C, is also inclosed. Dr. Low-Beer supervises the work, although Dr. Earl Miller has been named Project Director to coordinate the work with Dr. Stone in Chicago. There is also inclosed a copy of the financial statement for Project 48C for the period July 1, 1944 to March 31, 1945. Dr. Miller was informed that financial statements need only be submitted quarterly.
