TRAVEL COSTS.

THERE HAVE ALSO BEEN OCCASIONS WHEN THE TRUST TERRITORY APPARENTLY WAS UNABLE TO PROVIDE TICKETS AND PAY A PER DIEM FOR TRUST TERRITORY PERSONNEL PARTICIPATING IN AN ERDA/BNL MEDICAL SURVEY TRIP. IN THESE CASES ERDA PURCHASED THE TICKETS FOR THE TRUST TERRITORY PERSONNEL AND PAID THEIR OTHER TRAVEL EXPENSES DIRECTLY.

WE ARE WILLING TO USE EITHER OF THE ABOVE PROCEDURES, HOWEVER, IT IS OUR UNDERSTANDING YOU PREFER TO PAY A PER DIEM TO THE PERSONNEL PARTICIPATING IN THESE MEDICAL SURVEY TRIPS. ALSO WE UNDERSTAND DR. RIKLON HAS WRITTEN A LETTER TO DR. CONARD, BNL, IN WHICH HE STATES THAT HE UNDERSTANDS ERDA WILL PROVIDE THE TICKETS AND PAY THE TRAVEL COSTS OF THE PERSONNEL SCHEDULED TO PARTICIPATE IN THE UPCOMING TRIP.

SINCE WE HAVE BEEN UNABLE TO DETERMINE EXACTLY HOW THE TRUST TERRITORY WISHES TO HANDLE THIS MATTER WE HAVE PURCHASED THE AIR MIKE TICKETS AT KWAJALEIN FOR THE TRUST TERRITORY PERSONNEL SCHEDULED TO PARTICIPATE IN NEXT RV LIKTANUR VOYAGE. DR. KNUDSEN, BNL, WILL HANDCARRY THE TICKETS TO MAJURO ON MARCH 7, 1977.
