- a. Joint determination by the Commission with the DOD as to the transmissibility of "Fleet Air Defense Study" to the U. K. and Canada, scheduled for week of May 21.
- b. Joint determination by the Commission and the DOD as to the transmissibility of "Safety Tests at Nevada Test Site" to the U. K., scheduled for week of May 21.
- c. The Joint AEC-DOD Classification Guide.
- d. Reconsideration of AEC 111/49 "Security of Intelligence Agencies", action on this paper was previously deferred pending supplemental judgments, now submitted, by Directors of Security and Intelligence.


