THIS SUPPLEMENTAL AGREEMENT, entered into this 6th day of
April, 1954, between the UNITED STATES OF AMERICA
(hereinafter referred to as "the Government"), represented by the Contracting
Officer executing this Supplemental Agreement, and

WITNESSETH:

WHEREAS, the parties entered into Contract No. DA-49-007-MD-506
(hereinafter referred to as "said contract") which requires the Contractor to
conduct certain studies and experimental investigations as therein specified
during the period commencing 1 December 1953 and ending
30 November 1954, on an actual cost basis in an amount not
to exceed Six Thousand, Two Hundred Forty Five Dollars (\$6,245) and

MODIFICATION TO CONTRACT (Medical College of Virginia)

WHEREAS the Contractor is desirous of modifying sub-paragraph h, Overhead, of Article 4; and

WHEREAS the Government is desirous of modifying sub-paragraph o of Article 12, Disposition of Premises Altered or Constructed; and

WHEREAS this supplemental agreement is authorized by the authority of Section 2(c)(1) of the Armed Services Procurement Act of 1947, as amended (41 U.S.C. 151, et seq.) and Presidential Proclamation 2911;

NOW, THEREFORE, the parties do mutually agree to modify the contract in the following particulars, but in no others:

1. Sub-paragraph (h) of Article 4 is modified and changed so that, as modified and changed, it shall read as follows:

"(h) Overhead. An allowance for overhead costs not otherwise reimbursable hereunder in an amount equal to 10% of the total costs reimbursable under subsection a through g of this article, this percentage of overhead having been administratively predetermined to be a fair portion of the Contractor's overhead to be charged to the work under this contract for the period ending 31 January 1954. Commencing 1 February 1954, and continuing for the duration of this contract, the overhead allowance reimbursable under this contract shall equal the actual and applicable overhead cost incurred by the Contractor in the performance of this contract. The determination of such actual and applicable overhead cost shall be made annually by the cognizant auditing representative of the DoD, acting on behalf of the Contracting Officer, with the approval of the Contractor. Pending such first such annual determination, provisional payment of overhead cost shall be made on the basis of an overhead rate of 27.23% of salaries and wages. For all succeeding years, provisional payment of overhead cost shall be made, pending the determination of actual overhead cost, on the basis of the percentage determined upon the immediately preceding year. After determination of the percentage to apply for any year, subsequent payments shall be adjusted, or other adjustments made, for any overpayments, or underpayments occasioned by the use of a provisional overhead rate."

2. Sub-paragraph o of Article 12 is hereby deleted.

EXCEPT AS MODIFIED HEREIN said contract shall remain in full force and effect and the terms and conditions thereof shall apply to this agreement.
