### Surveillance Requirements

- Assessment process informs surveillance requirements
- Communicate requirements to PAs
- Update BG, BC, and BB documents as necessary
- Update TBSTP, QERTS, Reliability, and IWET plans
- In the future potentially CEPPC report updates

# Checks and balances <sup>exist</sup> in the LANL process for the development of surveillance requirements

- Annual surveillance analysis and reviews inform the development of surveillance requirements
  - Peer review of surveillance analysis and emerging requirements
  - Emerging diagnostics are critically reviewed
- Weapon physics and science community are consulted as part of the development process
- New requirements are reviewed/approved by Weapon Program Managers and upper management depending on impacts

# LANL is working toward development of a top level NEP Surveillance requirements management process

- **Use of DOORS (Dynamic Object Oriented Requirements System) to manage all surveillance requirements**
  - All levels of system requirements are captured and tracked in a database
  - External requirements
    - MCs, STS, ICDs, ...
  - Derived requirements
    - CDs, MEs, Product Spec's, Surveillance Spec's
- **Allows for verification and compliance status**
- **Configuration-controlled, links to configuration-controlled documents**

- Navy is issuing all requirements in DOORS format
- Air Force has purchased DOORS and is moving in the same direction
- PRIDE endorsed DOORS as the preferred RM Tool

# No new recurring requirements in the FY11 LANL Core Surveillance program from the NA-12 Tasking

- All activities in the NA-12 tasking memo have formally released surveillance requirements
- Annual Assessment has identified knowledge gaps that required additional tests to help understand
  - W76-0 and W88 CSA evaluations have increased
- B61 Systems group has established a system requirement to define a baseline for the B61 LEP through a 28 unit study
- New STP diagnostics are being developed for deployment in FYNSP
  - Vetted in CEPPC reports and presented in IWET
  - Jointly developed with the PAs and ESC for qualification and deployment

LANL surveillance requirements have been consistent with what was submitted in IWET Plans

# CEPPC recommendations for FY11

---

- **Guidance needs to be finalized by SEPWG**
- **After guidance is published CEPPC groups need to meet to assess status path forward once guidance is published**

CEPPC's would be a powerful, collaborative, and transparent way to improve and optimize the surveillance program
