Project Title/Name: Community Crowd-Funded Solar Finance

I. Accomplishment & Milestone Update

The non-profit sector – churches, schools, universities, homeowner associations, clubs and similar entities – has been largely excluded from the solar market. There is high demand for solar among these institutions, but the main stumbling block is that they cannot generally access traditional capital sources. This institutional capital is put off by both the transaction costs and the credit profile of these non-profit projects. Village Power Finance, Inc. ("VPF") intended to and has built an online platform that streamlines the development process and opens up a new source of funding for this sector: local capital, i.e. investment from the community members associated with each non-profit institution. VPF's platform wills designed to and now includes a crowd-funding engine that aggregates individual investment from within the community and, where needed, combines this with investment from accredited investors or entities seeking green assets and/or tax-enhanced investments. In addition, VPF uses the platform to manage the asset and provide real-time monitoring data to stakeholders. The net result of VPF's program is to lower the cost of capital for this sector and thereby facilitate a significant growth of solar installations at non-profit facilities. In particular, VPF's platform brings down the costs of due diligence and other transaction requirements.

VPF has launched and is operating a platform that is scalable and facilitates faster and less-expensive solar development in the non-profit sector. In addition, there are over 500 users on the platform, 5 funded projects and a pipeline of over 20MW (over 100 projects) in more than 4 states. The Platform is a robust site, where anyone can come and review projects underway. This includes access to a rich supply of data, including pictures, financial analysis, comments from participants and updates on the progress. In addition, the Platform permits anyone (subject to certain limitations, including minimum amounts) to invest in a Project with a minimal amount of input and without leaving the site. Further, users get real time data on each Project, including technical performance, cash flow and other financial data. The Platform also permits virtually anyone to commence a Project by filling in an easy-to-follow form.

II. Issues, Risks, and Mitigation

Village Power Finance has successfully completed the goals and requirements of the project.

III. Proposed Changes in Approach

The Project is completed, no current proposed changes in approach.

IV. Proposed Changes in Key Personnel

During the course of the project we added and subtracted members of the team as the company evolved, and provided notification accordingly to DOE Sunshot program managers. The program is completed so there are not current proposed changes in key personnel.
