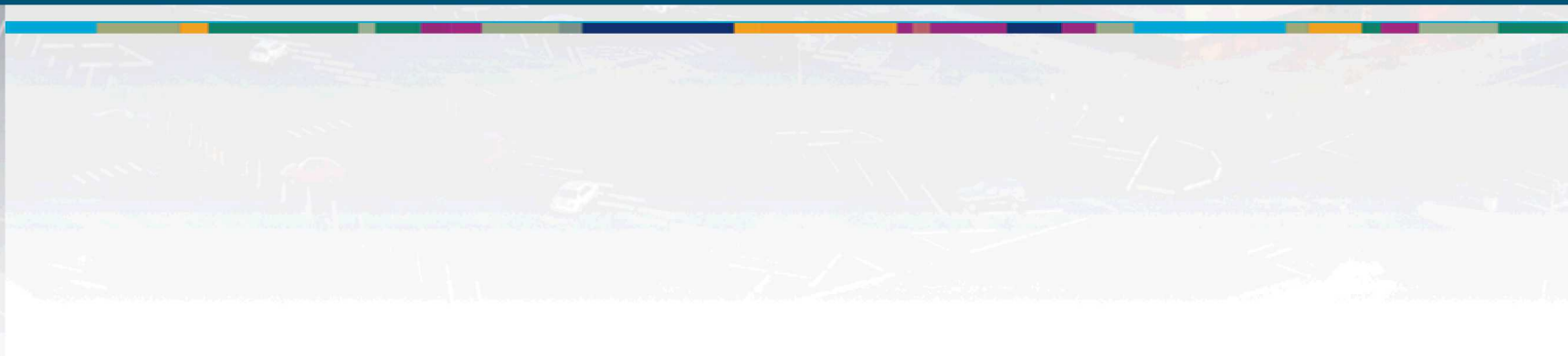
Partnership with ESARDA's Export Control Working group
