Sandia Corporation (Sandia) is requesting that the Department of Energy/National Nuclear Security Administration (DOE/NNSA) provide the enclosed affidavits to the New Mexico Environment Department (NMED) Hazardous Waste Bureau. The affidavits should be sent to the attention of Mr. John Kieling as required by the New Mexico Administrative Code, Title 20, Chapter 4, Part 2 (NMAC 20.4.2.211). Each facility is required to submit documentation by July 1 for hazardous waste management units that were not operated during the previous calendar year.

The hazardous and mixed waste management units described in these affidavits are units detailed in one of the following:

- Permit NM5890110518-1 (including Table A.2 in Module IV),
- Permit NM5890110518-2, or
- Part A permit applications

Affidavits are provided only for those units that were not used during 2011 for waste management activities that require a permit.
