**Notice of a Request for a Class 3 Permit Modification
to Module IV of Hazardous Waste Permit NM5890110518-1**

On behalf of the Department of Energy (DOE) and Sandia Corporation (Sandia), DOE hereby notifies you that DOE and Sandia are initiating a Class 3 modification for designation of one solid waste management unit (SWMU) as approved for no further action at Sandia National Laboratories/New Mexico (SNL/NM).

The SWMU under consideration is LTES Site 1, known as the Cable Debris Site. DOE and Sandia identified the SWMU in 2008, notified the New Mexico Environment Department (NMED), and completed corrective action under a plan approved by the NMED. In 2010, NMED determined that corrective action is complete at this site.

DOE and Sandia request that this SWMU be listed on Table A.2 "List of Solid Waste Management Units (SWMUs) and Areas of Concern (AOCs) not Currently Requiring Corrective Action" in Module IV of Hazardous Waste Permit NM5890110518-1. DOE and Sandia further request that no controls be required for this SWMU.

Comment Period. A 60-day public comment period associated with this permit modification request began on March XX, 2012. Comments on this request will be accepted through May XX, 2012. Comments should be directed to both:
