Please provide the following information to the New Mexico Environment Department (NMED), Hazardous Waste Bureau, to the attention of Mr. Steve Pullen, as required by the New Mexico Administrative Code, Title 20, Chapter 4, Part 1, Subpart II, (20.4.1.200 NMAC), incorporating Title 40 of the Code of Federal Regulations (40 CFR) Part 261.4(f). Each facility that performs treatability studies is required to submit a report to the authorized regulatory agency (by March 15 of each year) with the following information:

- Information on treatability studies performed during the previous calendar year, and
- An estimate of the number of treatability studies and the amount of waste expected to be used in treatability studies during the current calendar year.

During calendar year 2013, no treatability studies were performed at SNL/NM.

During calendar year 2014, no treatability studies are anticipated at SNL/NM.

In accordance with 20.4.1.200 NMAC/40 CFR 261.4(f)(1), Sandia Corporation will notify the Department of Energy (DOE) and request that DOE notify the New Mexico Environment Department (NMED) at least 45 days prior to the initiation of a treatability study at SNL/NM.
