Subject: ***Notification of Completion of Compliance Activity E, Section 4.0, of the Site Treatment Plan (STP), Compliance Plan Volume (CPV) and Request for Deletion of Covered Waste from the Federal Facility Compliance Order (Order), for Sandia National Laboratories, New Mexico***

Sandia Corporation (Sandia) is requesting that the Department of Energy/National Nuclear Security Administration (DOE/NNSA) submit to the New Mexico Environment Department (NMED) a notification for receipt of mixed transuranic (MTRU) waste at an off-site certifying facility. This notification is required by Section 4.0, Activity E, of the STP CPV of the Order, issued by the NMED on October 4, 1995, as revised and amended.

This notification will complete the following required activity, in accordance with the STP CPV, Revision No. 12:

Section 4.0, Activity E, *"Provide documentation to NMED that MTRU waste was received at off-site certifying facility within 45 working days of receipt of waste at certifying facility."*

On March 23, 2011, approximately 0.005 cubic meters (m³) of covered MTRU waste were shipped to the Advanced Mixed Waste Treatment Plant (AMWTP) at the Idaho National Laboratory (INL) for certification and subsequent shipment to the Waste Isolation Pilot Plant for disposal. Sandia has received the completed Uniform Hazardous Waste Manifest (UHW) from INL, signed on March 24, 2011. The notification letter includes a copy of the UHW from INL that serves as documentation that the waste was received at the off-site facility, completing Activity E.


Sandia is also requesting that the DOE/NNSA submit to the NMED this request for approval to delete 0.005 m³ of covered MTRU waste from the STP. This request for approval is based on Section IX.A.1 of the Order because the waste has been received at an off-site facility for treatment, disposal, or storage pending treatment or disposal.

The remaining waste volumes shipped to INL were not subject to the STP compliance requirements and deletion approval is not required.

As required by the Order, Section XX, "Documents, Information, and Reporting Requirements," Item D, "Certification Statements," the certification statement with my signature is provided with the original copy of the deletion request letter.

If you agree, please sign the enclosed certification statement, as required by Section XX.D of the Order, and submit the Notification and Deletion Request to Mr. William P.
