Security Levels

- **SECON 3:** An increased and more predictable threat of malevolent or terrorist activity exists.
- **FPCON Bravo:** Increased security measures capable of being maintained for weeks (Kirtland AFB).
- **COGCON 4:** Normal continuity of government operations.

Contacting Friends and Family After an Emergency

- After an emergency, you will want to reach friends and family to let them know your status. This is the right thing to do – but remember, everyone else will want the same thing. If you do not need emergency assistance, use text or internet-based messaging to contact loved ones. Text messages use fewer resources than phone calls and stand a much greater chance of being sent when the infrastructure is both damaged and overloaded. The “[AC Prepared](#)” app, published by the Alameda County Sheriff’s Office, allows you to simultaneously text multiple people your status after an emergency. This can be downloaded on both Android and iOS phones.
- In addition, have at least one out-of-state contact. Not only can this person serve as a point-of-contact for everyone to inquire about you, long-distance phone lines may be operable when local phone lines are not.

Monthly Messages

- All Members of the Workforce are encouraged to attend a session of the active shooter emergency preparedness and protective action training. Sessions will be held June 11th (10:00-11:00 AM) and June 12th (2:00-3:00 PM). Each session is open to everyone and will teach you what to do if an active shooter happens here. Although we are a secure site, we are not immune to the potential for tragedy.
- Emergency Management has officially transitioned to a new emergency notification system, Vesta Communicator. Your emergency notification messages will have a new look-and-feel and come from different phone numbers/e-mail addresses. Do not ignore these messages – they could contain vital, time sensitive information that will keep you safe.
- Do you know what to do if you have to Shelter-in-Place? Phase I means stay inside, avoid windows and doors, and wait for further instructions. Phase II means go to your indoor assembly area and seal air gaps to prevent hazardous materials from leaking inside. Don’t know where your indoor assembly area is?
