



NATIVE AMERICAN WORKSHOP ON PETROLEUM ENERGY

AUGUST 11-12, 1997, SANTA FE, NEW MEXICO

1.0 INTRODUCTION

Twenty-seven Native American tribal members, council members, and other interested parties gathered in Santa Fe, New Mexico, to attend the Native American Workshop on Petroleum Energy on August 11 and 12, 1997, sponsored by the U.S. Department of Energy and presented by BDM-Oklahoma, Inc. staff. Tribes represented at the workshop included the Jicarilla Apache, Pueblo of Acoma and Ute. Representatives of the Environmental Protection Agency (USEPA), Bureau of Indian Affairs (BLA), Bureau of Land Management (BLM), and Minerals Management Service (MMS) also attended. A list of attendees is listed in Appendix A.

BDM-Oklahoma developed and organized the Native American Workshop on Petroleum Energy to help meet the goals of the U.S. Department of Energy's Domestic Gas and Oil Initiative to help Native American tribes become more self-sufficient in developing and managing petroleum resources.

1.1 PLANNING & PRE-CONFERENCE ACTIVITIES

A brochure was developed and mailed to tribal contacts and tribal members who are on a mailing list compiled by BDM-Oklahoma. The brochure included a description of the courses offered in the training program, a training schedule, and course registration materials. The training program was announced on the National Petroleum Technology Office (NPTO) home page. In addition, BDM-Oklahoma staff worked with the BIA, the Council of Energy Resource Tribes (CERT), and the American Indian Science and Engineering Society (AISES) to make the information and registration materials available to interested tribal members.

1.2 DESCRIPTION OF WORKSHOP PROGRAM

The course content and presentations were developed from prior discussions with several tribes. As was expected, a broad spectrum of desired information was identified during the discussions; however, the course content was set to meet the largest audience and time constraints for the workshops as shown in the agenda in Appendix A.

1.3 WORKSHOP LOCATION

The workshop site was selected to be convenient to several native American tribal reservations in New Mexico, Arizona, Colorado, and Utah. Several of the tribes in this region have tribal-owned companies exploiting their natural resources and in some instances are considering processing the recovered resource into a consumer product. For example, tribal oil and gas companies are considering refining the oil produced on their reservations.

Santa Fe, New Mexico, Workshop




Figure 1 Location of several tribal areas around Santa Fe, New Mexico.

Santa Fe is the center of several pueblos, as well as convenient to larger reservations of the Jicarilla Apache, Navajo, Ute, and Hopi reservations as shown in Figure 1. Several native American tribal cultures interact in the town square of Santa Fe. Craftsmen and vendors from several tribes comprise the open market in Santa Fe's market square. Many of the conference participants toured the town of Santa Fe and walked to the town square.

Workshop Accommodations

The workshop was held in the Hotel Santa Fe, the only Native American owned hotel in Santa Fe. The meeting rooms and conference facilities were well suited for groups of up to 120 people. Because the workshop group contained approximately 30 people, the center was excellent.

The hotel is owned by the Picuris tribe. Once one of the largest northern pueblos early in the fifteenth century, today the Picuris population has shrunk to less than three hundred. Still, Picuris life today is marked with many of the traditional ceremonies which have been revived and can be seen throughout the year. The Feast of St. Lawrence brings Sunset Dances and races in which all ages participate, and there are Corn Dances and Buffalo Dances in June and August.

1.4 TRIBAL PARTICIPANTS

Registration for the conference was received from several tribal groups as shown in the registration list in Appendix B. Included in the list are attendees from other government agencies who assist the tribes with various tasks associated with mineral resource exploration and exploitation.

1.5 THE CONFERENCE

The conference provided introductory training in petroleum energy topics to members of Native American Tribes who manage tribal mineral holdings, set policy, or work in the oil and gas

industry. Participants gained a broad perspective in petroleum geology hydrocarbon exploration and technologies that enhance hydrocarbon production.

Presentations by BDM-Oklahoma and BDM Petroleum Technologies technical staff included an overview of petroleum geology focusing on how oil is formed, trapped, and discovered. Geologic tools and technologies employed in the discovery and recovery of petroleum were discussed using field data and examples. An introductory session on production technology included a historical perspective, oil field terminology, information about leasing and owners' rights, and an overview of primary and secondary production methods and new technologies, such as improved oil recovery technology.

On the second day of the conference, a workshop on managing and complying with federal environmental regulations that impact hydrocarbon exploration, drilling, and production operations generated a great deal of interest. The final session, entitled "Introduction to Petroleum Processing," was added to the workshop in Santa Fe. It provided the participants with an overview of processing design and operation. The presentation included unit

requirements, integration, and operation. Examples from various economic requirements were used to illustrate the type of capital requirements needed for construction and operation.

BDM-Oklahoma supported the conference with a tabletop exhibit and several tables of reports of technical work funded by BPO and conducted on Native lands. The technical reports and other materials were well received by participants.

2.0 INTRODUCTION TO PETROLEUM GEOLOGY

The first session of the two-day Native American Conference on Petroleum Energy was conducted as an introduction to petroleum geology in exploration and exploitation operations. Development of oil and gas prospects for drilling were discussed by introducing participants to the process that geologists use to generate and confirm prospects. Exploration prospect development begins with subsurface mapping of formation tops from geological data or electric logs. The prospective area is confirmed with 2D seismic data and detailed with 3D seismic data if economics justify the cost of conducting a 3D seismic survey. Examples of correlated electric logs and seismic profiles were presented by viewgraph to give participants an idea of the types of data that geologist evaluate and map. Potential targets for various areas are either known from geology of hydrocarbon-producing formations in nearby fields or in frontier areas, by projecting surface geology into the subsurface from surface outcrops. Viewgraphs were shown to the participants of schematic diagrams of seismic wave propagation from a surface source to a reflector bed in the subsurface back to surface geophones and recording devices. Photographs of Vibroseis vibrator trucks and recording trucks in the field were shown to familiarize participants with noninvasive methods of acquiring seismic data.

3.0 OIL AND GAS PRODUCTION

The second session on the first day of each workshop opened with an overview of the oil and gas industry from Colonel Drake's oil discovery in Pennsylvania in 1858 to current day operations. The overview included a history of the petroleum industry and the function of a typical oil company. It was pointed out that the majority, by far, of the wells currently producing in the United States are marginal and stripper wells owned and operated by small independents.

Petroleum industry practices were discussed along with examples. Government regulations, petroleum imports, exploration practices for oil and gas, drilling techniques and methodologies, production methodologies, marketing, recent technology advances, and the future were covered. Drilling rigs, producing wells, and subsurface diagrams were shown and discussed in the context of how producers find and produce petroleum. It was pointed out that well spacing on regular 5-, 10-, 20-, 40-, 80-, 160-, 320-, or 640-acre units is regulatory spacing rather than spacing for the architecture of the reservoir. Mineral rights, drainage, and severed minerals from the surface were defined and described, as these pertain to both non-Native American lands

and Native American lands. The importance of insurance, bonds, and liability for regulatory control over environmental contamination, blow-out while drilling, injury, abandonment of produced out wells, etc., provided areas for instruction and discussion. Petroleum and the environment were touched upon as an introduction to increased regulatory control over the petroleum industry. Subsurface construction of wells for production was described and shown on a viewgraph. The basics of petroleum production were discussed in this session, along with drilling and production costs to operators and the price of domestically produced oil. Production practices included improved oil recovery processes such as chemical flooding, miscible gas flooding, and thermal flooding technologies. Introductory materials on coal-bed methane production was included, as well as reservoir characterization and well completion.

4.0 FEDERAL ENVIRONMENTAL REGULATIONS IMPACT IN HYDROCARBON EXPLORATION, DRILLING, AND PRODUCTION OPERATIONS

Federal environmental regulations impacting hydrocarbon exploration, drilling, and production operations were discussed along with examples of violations, penalties and fines for violations, and economic impacts of implementing environmental regulations. Federal environmental regulations covered in the workshop are the Resource Conservations and Recovery Act (RCRA), Safe Drinking Water Act (SDWA), Clean Water Act (CWA), Comprehensive Environmental Response, Compensation, and Liability Act (CERCLA), Superfund Amendments and Reauthorization Act (SARA), Clean Air Act (CAA), Toxic Substances Control Act (TSCA), Oil Pollution Act of 1990 (OPA), Migratory Bird Treaty Act, Endangered Species Act, and Hazardous Materials Transportation Act (HMTA).

5.0 PETROLEUM REFINING AND PROCESSING

The Introduction to Petroleum Processing provided the participants with an overview of processing design and operation. The presentation included unit requirements, integration, and operation. Examples from various economic requirements were used to illustrate the magnitude of capital requirements needed for construction and operation. Environment protection requirements were discussed to illustrate their impact on the proper unit design and construction.

6.0 EVALUATION/FOLLOW-UP

Evaluation forms were passed out to participants following each workshop session. Also, a follow-up packet with a letter, certificate, list of participants, handouts, and other requested materials was sent to each conference participant.

The feedback from the evaluation forms are summarized in Table 1. Overall, the participants were pleased with the content of the conference and recognized the potential to tailor presentations to specific tribal locations. A few comments expressed a desire for in-depth technical information. If the audience had been more homogeneous in its technical background, more in-depth training could have been designed. Several tribes requested future workshops discussing the specific production technologies used to produce oil and gas from the reservoirs on their reservations. Discussions with the various tribal councils are ongoing to obtain permission to make the presentations in their tribal offices. The presentation will be tailored following an evaluation of each tribe's reservoirs and production history.

7.0 SUMMARY

Twenty-seven Native American tribal members, council members, and other interested parties gathered in Santa Fe, New Mexico, to attend the Native American Workshop on Petroleum Energy on August 11 and 12, 1997, sponsored by the U.S. Department of Energy and BDM-Oklahoma, Inc. Tribes represented at the workshop included the Jicarilla Apache, Pueblo of Acoma, and Ute. Representatives of the USEPA, BIA, BLM, and MMS also attended. A list of attendees is listed in Appendix A.

As shown in Table 1, the majority of the participants indicated that the workshop met their needs and would be useful to them. Comments on the individual evaluation forms also indicated a need for a more in-depth workshop for various aspects of oil and gas exploration and exploitation.




