**Location:** Twisp, Okanogan County, Washington

**Proposed by:** Bonneville Power Administration (BPA) and the National Fish and Wildlife  
Foundation, implemented by the Washington Water Trust

**Description of the Proposed Action:** BPA proposes to fund several water rights acquisition projects proposed by the Washington Water Trust (WWT). The funding will be administered by the National Fish and Wildlife Foundation, the entity administering the Columbia Basin Water Transactions Program, initiated under RPA 151 of the National Marine Fisheries Service's 2000 Biological Opinion on the Operation of the Federal Columbia River Power System. The water rights acquired by the WWT will be left instream to increase flow and improve water quality. Increasing instream flow of water-limited streams benefits fish listed under the Endangered Species Act.

The three projects proposed by the WWT include: renewing a lease for 0.43 cubic feet per second (cfs) in the Methow River for three years; renewing a lease of 1.29 cfs to be protected in a 0.75 mile stretch of Gold Creek, a tributary to the Methow River, for one year; and renewing a lease of 0.17 cfs in a 0.2 mi stretch of Frazer Creek, a tributary of the Methow River, for two years.

**Analysis:** The compliance checklists for these projects were completed by Peter Dykstra and Lisa Pelly, WWT, and meet the standards and guidelines for the Watershed Management Program Environmental Impact Statement (EIS) and Record of Decision (ROD).

The proposed projects are located in the Methow River and tributaries in north-central Washington. The transactions are all renewals of existing short-term water rights leases. The WWT program benefits listed fish species by perpetuating the short-term leases, though none of the proposed transactions are permanent. By funding the current transactions, BPA will

temporarily protect against the risk that the water rights will again be used consumptively. Because the proposed transactions will maintain the status quo, BPA has made a determination that the proposed projects will have no effect on fish and wildlife species listed under the Endangered Species Act.

No other environmental review or consultation is required as part of the proposed projects, because there is no ground disturbance or construction associated with the proposal. The WWT has a program for public involvement, including holding public meetings and using the local media to provide information and solicit comments. The WWT has printed announcements about the proposed projects in the local paper in March 2003, and the proposals were the subject of an article in the local paper. WWT has also coordinated with several regulating agencies that have their own public notice requirements, such as the Washington Department of Ecology.

**Findings:** The project is generally consistent with the Northwest Power Planning Council's Fish and Wildlife Program, as well as BPA's Watershed Management Program EIS (DOE/EIS-0265) and ROD. This Supplement Analysis finds that: 1) implementing the proposed action will not result in any substantial changes to the Watershed Management Program that are relevant to environmental concerns; and 2) there are no significant new circumstances or information relevant to environmental concerns and bearing on the Watershed Management Program or its impacts. Therefore, no further NEPA documentation is required.
